Reynard Health Supplies, following agreement with the Therapeutic Goods Administration (TGA), is conducting a Critical Quarantine of the below products. The potentially affected products have been supplied to your organisation.

| WHAT IS THE PROBLEM?     | <ul> <li>The TGA has received reports of potential Achromobacter contamination. It has been determined a likely source of contamination is materials and products associated with the manufacturer Baoying County Fukang Medical Appliance Co Ltd.</li> <li>While the investigation into the potential contamination is ongoing, it has not been determined if the above products are affected. However, out of an abundance of caution, products from this manufacturer are to be quarantined until further notice.</li> </ul>             |

| WHAT IS THE HAZARD/RISK? | <ul> <li>The TGA has limited information at present about the causal factors behind the infections and cannot confirm that it is due to these therapeutic goods. While the investigation is ongoing into the potential contamination, it has not been determined if the above products are affected.</li> <li>If the products are confirmed to be contaminated with <i>Achromobacter</i> species, this can potentially result in serious infections, which may be life-threatening for patients with compromised immune systems.</li> </ul> |
